MINOR PASSENGER AGREEMENT FOR LIMOUSINE SERVICE

All parties entering this contract including the limousine company, the teenage passengers and the parents agree to the following:

1. It is unlawful for a minor to possess or consume alcoholic beverages.
2. There will be **no alcoholic** beverages or illegal substances transported in the passenger compartment or carried in the trunk, or any other locked compartment of the vehicle.
3. If it is determined, at any time, that any passenger(s) are found to have in their possession, or have been at any time during the course of the service consuming alcohol or an illegal substance, the service shall be terminated, then and there. Parents will be required to pick up their children.
4. If termination results, all money shall be forfeited and a parent or guardian shall be notified.
5. There will be absolutely **no smoking** in the vehicle.
6. At no time during the course of the service will individuals not entered on page 1 of this agreement be permitted access to or transportation in the vehicle or its compartments.
7. Due to high risk insurance factor, both the moon roof and the privacy partition will be rendered inoperable throughout the transportation services. Divider window (if equipped) will be open at all times allowing supervision by chauffeur.
8. Each parent of a teen passenger must provide a phone or cell phone number in case of violation or emergency.
9. In case of any passenger list changes, a supplemental passenger list will have to be completed.
10. Signatures beside each name indicate that this contract has been read and accepted by the parents and passengers listed.

Last Nite Limos, will not be held liable for circumstances beyond our control including but not limited to road conditions, mechanical breakdowns and weather. I, the undersigned, agree to pay the balance due at the pick-up. I understand, if cancellation is made there will NO REFUND of deposit after the grace period. Client is responsible for all costs involved in collection of this billing including but not limited to court and attorney's fees. It is our goal to provide the exceptional service for your prom day. We will reserve this date & time and the vehicle you requested. In the unlikely event of the vehicle breakdown we reserve the right to substitute for a similar vehicle to accommodate your needs.
